IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball under the auspices of GLBC, I acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist;
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability below, and assume full responsibility for my participation; and,
3. I understand that the activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS GLBC, the owners and lessors of premises used to conduct the paintball activities, their officers, officials, agents and/or employees ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct.
5. I expressly agree that that foregoing waiver is intended to be as broad and inclusive as is permitted by the law of the Province of British Columbia in which the paintball games and activities are conducted and that if any portion is held invalid, it is agreed that the balance shall, nevertheless, continue in full force and effect.
6. I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event in which I participate hereafter.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

PLEASE READ AND INITIAL (INT) EACH POINT BEFORE SIGNING BELOW

INT _____ **I understand that by following these rules and guidelines, I will be able to minimize the risk to myself and others.**

INT _____ I will attend a formal briefing session where all the safety rules will be explained to me.

INT _____ Always follow the instructions of the Marshals and abide by their decisions.

INT _____ Never fire anything from your Paint Marker other than the Paintballs provided.

INT _____ Your goggles must be worn **at all times** on the game field once you leave the "Safety Zone".

INT _____ All protective equipment will be checked to make sure that they are properly fitted before start of game

INT _____ Paint markers are NOT allowed in the "Safety Zone". When not on the game field markers must remain on the racks provided.

INT _____ No physical contact is permitted.

INT _____ Do NOT shoot your marker at anyone not involved in the game.

INT _____ Do NOT fire your gun once you leave the game field other than at the designated firing range.

INT _____ Do NOT leave the game fields during play. Stay within the defined boundaries.

INT _____ Do NOT shoot at people closer than 20ft.

INT _____ Do NOT deliberately aim at the head or face. Shots are allowed only below the neck.

INT _____ Do NOT fire if you can't see what you are firing at. No Blind Firing.

INT _____ Do NOT deliberately shoot at any wild animals.

INT _____ No knives or weapons of any description are allowed on site.

INT _____ Please respect the countryside.
